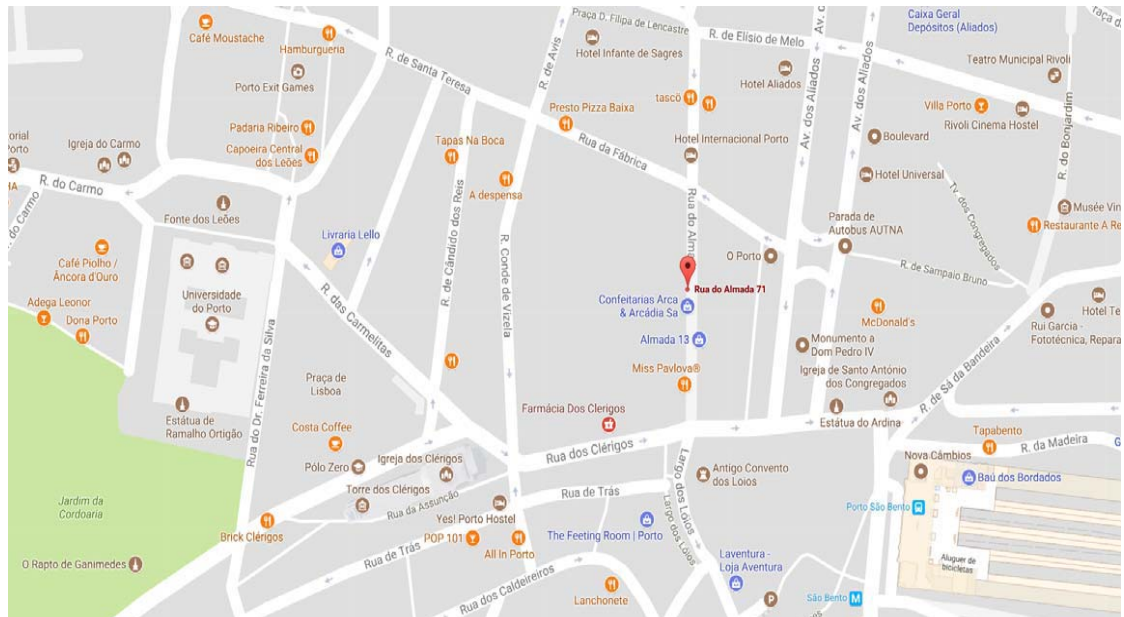

To get from the airport to the center you can either take a taxi (approx. 20 minute ride) or the subway (Purple line heading to *Estádio do Dragão* and exit at *Trindade* station). Then take the Yellow line and exit at *Aliados* or *São Bento*).
